Two main economic systems coexist in **contemporary** society: market economy and central planned economy.

Market economy is a free market which is guided by supply and demand.

II processo

We have filed a **civil action** against your firm.

Parte civile

The company will be tried for **negligence**. Irresponsabilità

Since all efforts to achieve a compromise have failed...

Giungere ad un compromesso

...it is our decision to **prosecute** your firm. Faure causa, intentare giudizio

We believe we are **entitled** to compensation.

Abbiamo diritto

We presented the **statement of claim** last week.

Atto di citazione

The court will have to determine **liability** in this matter. Responsabilità

Did the court receive the **statement of the defence?**Comparsa di costituzione

We have provided our lawyer with a **Power of Attorney**.

Procura

We have complete confidence in his **integrity**. Integrità

He will collect a **deposition** from all witnesses before the trial.

Deposizione

A witness' **affidavit** may serve as evidence.

Affidavit

The **prosecuting attorney** will start the trial.

Pubblico ministero

He will present his **allegations** before the court.

Allegazioni

The second stage of the proceedings will be the defence plea.

Patteggiamanto della pena

The attorney for the defence will speak on behalf of his client.

Avvocato della difesa

The accused can plead innocent or guilty.

When this stage is over, the prosecution will be recalled for a **replication**.

Replica

A case can not be based on **speculations**.

Congetture

Evidence will be **submitted** in support of claims.

Presentato/a

The prosecutor may want to call witnesses to the court to give **testimony**.

Deposizione

...of course he will try to offer some **conclusive** evidence.

Prova schiacciante

Even an eye-witness' testimony can be **controversial**.

Controverso

All the evidence or testimony must have relevance to the case.

Rilevanza, pertinenza

The attorney for the defence is then called for a **rejoinder**.

Replica

He will offer the defence's **point of view** to the allegations.

Punto di vista

He may also raise **objections** to some of the claims.

The defence may want to **cross examine** the witnesses.

Sottoporre a controinterrogatorio

They will try to present the **evidence as conflicting**.

Prove contraddittorie

The **proceedings** will continue, until the judge reaches a verdict.

Le azioni giudiziarie

The judge will **take into consideration** all the evidence, before making his decision.

Prendere in considerazione

The judge will give a **verdict** based on the arguments presented.

Verdetto

... after which he will pass **sentence** on the guilty party.

Condanna, pena

All law costs will be covered by the losing party.

Le spese giudiziarie

Either party can **lodge an appeal**, if it feels justice has not been served.

Proporre un ricorso

This appeal will be discussed in the **Court of Appeal**.

Corte d'appello

In matters of public interest, a **petition** may be filed. Istanza

Sometimes the **Supreme Court**, the highest instance, will be asked to rule in these matters.

Corte Suprema

The Supreme Court's ruling may set a precedent.

Creare un precedente

The precedents may be resorted to as **reference** in future proceedings.

arbitration

Arbitrato

In case of **dispute**, the differences between the parties will be submitted to arbitration.

Disputa

Both parties would like to reach a **settlement** without going to court.

Intesa

Any disputes arising in connection with this contract shall be finally settled by **arbitration**.

Arbitrato

Each party will appoint its own arbitrator and the **arbitration court** will nominate a third.

Corte di arbitraggio

The arbitration tribunal shall consist of two arbitrators and an **umpire**.

Arbitro

The umpire will be nominated by the court... L'arbitro sarà nominato

...in order to prevent any **conflict of interest**.

Conflitto di interessi

Each party will appear before the tribunal and present its **arguments**.

Argomenti

The arbitration will suggest a fair **compromise** to the parties.

Compromesso

The parties agree that the **award (or ruling)** shall be obeyed and observed by both.

Sentenza

Both parties have to comply with the resolution.

Attenersi alla risoluzione

The arbitration is as **binding** as a court ruling.
